### Report Summary

Guangzhou Guose Intelligent Technology Co., Ltd., known in Chinese as 广州市国色智能科技有限公司, is a legally registered company in China. Established on June 4, 2007, in Guangzhou, Guangdong Province, the company has been in operation for 17 years. The legal representative is Xiao Wenyong. The registered capital is 13.75 million RMB (approximately 1.88 million USD). Neither the company nor its legal representative has any record of dishonesty, nor are they involved in any enforcement actions. The company has zero high-risk records.

The company is also a certified supplier on Alibaba, with over 5 years of certification, and operates its own independent website, guosegroup.com, which was registered on June 20, 2023.

### Credit Grade

Based on all available information, Guangzhou Guose Intelligent Technology Co., Ltd. receives a B credit grade.



### Actions to Take

**In general, funds are secure, but caution is advised for orders over \$200,000. There might be minor issues with post-purchase support. Buyers should exercise caution for larger or more complex orders and consider setting clear terms in their contracts to avoid potential complications.**

## Credit Systems

Our A-F credit system provides a structured way to evaluate the reliability and risk profile of companies based on their legal standing, financial stability, operational history, and customer feedback. D	<p><b>Below Average Credit Rating</b></p> <p>A "D" rating signals that while the company is legally registered and its legal representative is not involved in enforcement actions, it has only recently been established. The company has been operating for less than 12 months, meaning it has little to no history of business activity. This grade indicates that the company is still in its early stages of operation, and there is insufficient evidence to gauge its stability and reliability in the market. Given its limited operational history, potential partners or investors should approach with caution, as there are inherent risks involved in working with such a young company.</p> <p><b>Actions to Take</b></p> <p>There is significant risk to the safety of funds. For initial orders, it is recommended not to exceed \$5,000, and payments should be made in installments. If possible, choose other companies that have higher credit grade (A, B, or C).</p>

	<p><b>Poor Credit Rating</b></p> <p>A company rated "E" is legally registered, but there are significant red flags regarding its legal standing. While the company is officially recognized, either the company, its legal representative, or the major shareholders are involved in enforcement actions. This indicates that the company has been involved in legal disputes or financial difficulties that have led to court-enforced actions. As a result, companies rated "E" pose a much higher risk due to their legal entanglements, and potential partners or investors should proceed with extreme caution when considering doing business with them.</p> <p><b>Actions to Take</b></p> <p>The risk is high, and it is strongly advised not to do business with such companies, but with companies that have higher credit grade (A, B, or C). If no alternative suppliers are available, consider making payments in person or using a third party for direct transactions.</p>
	<p><b>Unregistered or Nonexistent Company</b></p> <p>A company rated "F" is the lowest level on the credit rating scale, indicating that the company is not legally registered or does not exist at all. This means that the business does not have official recognition, and there are no legal guarantees or protections for partners or investors. Companies with an "F" rating are considered extremely high risk and should be avoided entirely. Any business dealing with a company rated "F" is exposed to significant legal and financial risks, as the company may not operate within the boundaries of the law or have any legitimate operations.</p> <p><b>Actions to Take</b></p> <p><b>Do not do business with companies rated "F"</b> under any circumstances. 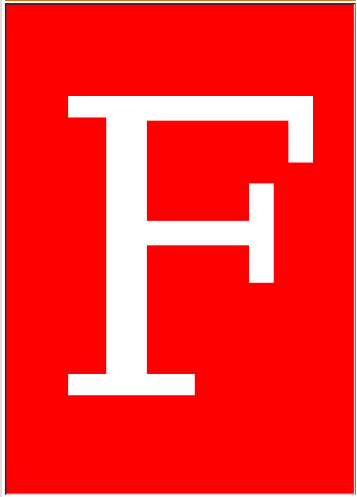
